(a)	Figures in ( ) mentioned in Total for I, denotes fee payable by SC/ST/PH students as they are given 100% exemption from tuition fees.
(b)	The most economically backward students (whose family income is less than Rs.1 lakh per annum) shall get full remission of the tuition fee.
(c)	The other economically backward students (whose family income is between Rs.1 lakh to Rs.5 lakh per annum) shall get remission of 2/3 <sup>rd</sup> of the tuition fee.
(d)	Ordinarily students are expected to live on campus. In very rare cases permission may be given to stay outside provided justifiable reasons obtained.
(e)	Students permitted to take Semester Break/Temporary Withdrawal etc. from the programme for one or more semesters are required to pay Rs. 2000/- as continuation fee per semester.
